I recall your remarkable contribution to recognize new born country Bangladesh in April 4'^ 1972, at that time you were a brave young senator from the State of Delaware that protested against US Secretary of State, Henry Kissinger. I also recall the heroic contributions of former Massachusetts Senator Late Ted Kennedy. I along with all the Bangladeshis will always appreciate you for your fight to establish Human Rights across the globe especially in Bangladesh. I am the dual bonafide Citizen of Bangladesh (By Born) and United States of America (Adjustment of Diplomatic Visa).

I currently live in the State of New Jersey; I have lived in Ventnor, Atlantic City and Egg Harbor Township since 1999. From 1985 to 1999 I was the inhabitant of State of New York, lived in Manhattan, Brooklyn and Queens. Many of family members are still living in the State of New York.

I am accredited and designated to the UN Headquarter New York, USA, Geneva, Switzerland, Vienna, Austria, Adis Ababa, Ethiopia, European Union, Commonwealth Secretariat of UK, QIC (Organization of Islamic Cooperation) Jeddah, KSA, The White House of Washington DC, USA through the Dayemi Complex Bangladesh, (DCB UN Inc.) UN Secretary General Designated Peace Messenger Organization since 1985, Chief of the Mission of World Human Rights Service Council, New York, USA, President, World Spiritual Assembly, New York USA since 1985, Secretary-General of Bangladesh United Nations Association at

Dhaka and New York since 1972, Secretary General International organization for world peace disarmament, development and Human Rights since 1989, Secretary-General World Federation of United Nations Peace Messenger Organization, New York since 1987. I was nominated two times for the candidacy of Noble Peace Prize in 2008 and 2010; I am a Researcher, Modern Prophet, Philosopher, historian and religious and spiritual leader 43^\textsq.\textsq. Direct Descendant from the Prophet of Islam Hazrat Mohammad SM (PBUH).

I am also the Writer of Historical Authentic Encyclopedia of World History, I had visited more than 186 countries through the United Nations System to attend more than 700 International conferences, symposiums, roundtable table meetings of the United Nations. I had proclaimed as Capacity of being the Pioneer Spokesmen of "The Millennium Prophecy Statement Heralds a Golden Age, to co-create Heaven on Earth and the Arrival of Jesus Christ for establishing Global peace around the World after 2020" at Earth Summit and Global Forum at Rio De Janeiro, Brazil on June 6*^ 1992 which was attended by 116 heads of states, 30,000 intellectuals, scientists, and spiritual leaders along with Civil Society Representatives of the World; my concept is that, "Human beings are the Crown Creations of Almighty God, Descendant of Prophet Abraham (PBUH), "Jews, Christians and Muslims are Cousin Brothers", "Than why are they fighting with Each other? Because of the fanatic belief and malpractice of reality of theology; Muslims, Jews and Christians do not understand Prophet Abraham's Ideology. No one shall dominate in a War or Fight. The fanaticism of So-called, Muslims, Jews and Christians as well as World's Political Dilemma must be stopped to avoid World War 3". Since 1985 I had been researching the Old Testimony of Bible of Christianity, Torah of Moses, Zabur of King David and Holy Quran in reference of my gigantic historic book Millennium Prophecy Statement ISBN: 97805- 786-2640-6, Ahlul Bayt ISBN: 97805-786-47722. I had established more than 100s of Educational Institutes which includes Schools, colleges, Madrasha and place of Worship (Mosques) as well as 7 International Orphanages in the rural areas of Bangladesh; the estimated cost of my projects can amount up to billion dollars.

My complaint is against the current fascist government Sheikh Hasina Prime Minister of Bangladesh and her gangsters, officials. She had been in power by the direct initiative of Indian RAW'S Chief Sheikh Hasina's best friend. President of India late Pranab Mukharjee of Calcutta, India. The Hindu fundamentalists' regime and government of India, destroyed the back-bone of East Bengal after the 1947's separation from East India company later again in 1971 by Prime Minister of India Late Indira Gandhi and her gangsters with department of RAW whom made long-time conspiracy and blueprint to separate the East Pakistan from West Pakistan to dominate and rule as their free colonial territory. They started the chaos and complexities amongst West and East Pakistan; West Pakistan's Armed forces understood that, they can't continue the legacy of Islamic Republic in East Pakistan because of its geographical territories also the peoples were mostly illiterate and majority were living subsistent below poverty as well as being surrounded by Indian rivers and territories even though the land was more resourceful with minerals and natural resources. Finally Pakistani 93,000 strongest soldiers of the World surrendered to the Indian aggression in the undeclared 13 days war; during the undeclared 13 days of war Indian Army and so-called freedom fighters of Bangladesh's self-proclaimed regime killed many peoples inside the East Pakistani territories and blamed on the West Pakistan's soldiers; under such circumstances India infiltrated East Pakistan and took the position to separated and liberated it and given birth to Bangladesh, which was headed by Indian RAW'S Chief Pranab Mukharje and other Hindu Fundamentalists fascist groups.

On 10'^ of January 1972,1 had arrived from my village area of Chittagong to the Capital Dhaka of New born country Bangladesh, as born brought up social philanthropists, religious and spiritual personality. Upon my arrival in Dhaka City, I had witnessed the scenes of horrible so-called celebration festival because of the arrival of Hypocrite Sheikh Mujib from Pakistan Jail via London and short stopover in India and returned back to Dhaka that afternoon. Many hypocrites and greatest dangers of mankind and Bangladeshi immoral Citizens as so-called liberation freedom fighters had welcomed and received hypocrite Sheikh Mujib at Dhaka Airport and brought him to the race course field of Dhaka; where Sheikh Mujib Proclaimed himself as the "Father of the Nation" and President of the new born Bangladesh. Hypocrite Sheikh Mujib also proclaimed himself as "Bongobundhu" meaning "Friend of Bengals" even

though he didn't take any part in the liberation movement of Bangladesh. All the aforementioned titles were his own self-proclaimed evidence to show off to the people for his first speech after 9 months.

However, India first given the recognition for their greatest interest to new born country Bangladesh; but the United States of America, United Nations and other World Federations had not recognized proclamation of Bangladesh as new born country till 1974.1 myself, met with the Sheikh Mujib being accompanied with Sheikh Mujib's Uncle Hafiz Monir Hossein of Armani Tola whom was his Business partner and friends in politics along with Qari Mohammad Obaidullah of Chowk Bazar Mosque (Grand Imam) renown personalities of Dhaka, Asafudoula Reza Senior Journalist Executive editor of Daily Ittefaq, and Alim uz'zaman Regional director of Bangladesh Radio; Sheikh Mujib's gangster Minister Mizanur Rahman Chowdhury, Home Minister Captain Monsur Ali along with other country patriotic leaders and elites of the City Dhaka. Finally on 23ⁿ⁻⁶ March I officially received a courtesy call by the first President of Bangladesh Mr. Justice Abu Syed Chowdhury from his Presidential palace Bongobhobon,

Dhaka as capacity of being selfless, social administrator also as religious and spiritual leader to meet him at the Presidential Palace.

After one hour cordial meeting with the President, we discussed the current situation of Bangladesh; how war had affected the fellow citizens, whom were victimized by the so-called liberation Army of India; the scarcity of food, medical supplies and humanitarian aids which was leading to the humanitarian crisis in new born Country Bangladesh. On the other hand, one of the big superpower United States of America and United Nations had not recognized new Born Country Bangladesh because of US's Secretary of State Henry Kissinger. I had suggested and proposed to President Justice Abu Sayed Chowdury as he was one of the country patriotic, educated personality and good Muslim; for the international recognition of the new born Bangladesh and for that we should urgently advocate and lobby at the international platform. Which led to the establishment of United Nations Bangladesh Jatishongho (Bangladesh United Nation's Association) organization; and It's President Hafez Monir Hossain of Armani Tola, Sheikh Mujib's business partner and friend; myself A.K.S.M.N Alam the founder Secretary General along with other 21 members of the executive committee patronized by President Justice Abu Syed Chowdhury.

After arriving in Dhaka I started my humanitarian services for the needy peoples by providing medical assistance and properly taking care of the elderly and war victims through the active help and support from the International committee of Red Cross Switzerland and other international humanitarian organizations. While I was dedicatedly helping, supporting and working for the war victims and needy peoples; I had witnessed many undesirable activities of Sheikh Mujib's regime and his gangsters; most importantly his elder son Sheikh Kamal, his cousin brother Sheikh Faziul Hoque Moni, atheist poet Shamsur Rahman of Daily Newspaper "Doinik Bangla". On June 17th of 1972 I had an altercation with Sheikh Mujib's immoral son Shiekh Kamal, and again next day on 18th of June 1972 while I was attending a red-cross conference with the International officers for humanitarian aid organizations held at the Intercontinental Hotel of Dhaka; I again had another altercation with Sheikh Kamal while he was aggressively charging on to bureaucrat officer Senior Secretary Abu Mohammad Obaidullah Khan (CSP) of Bangladesh to show off his illegal power; upon witnessing such incident, I had protested against Sheikh Kamal for his illegal charge against CSP Abu Mohammad Obaidullah Khan and other Immoral activities; On that very night of 18th June of 1972, while I was staying at an International Officer's guest house at Dhanmondi, Road #2 in front of 6DR Gate #2, Suddenly at 11:45 pm Sheikh Kamal and Shafiul Alam Prodhan of Chatro League along with Sheikh Mujib's Political Secretary Tofael Ahmed in a Military Uniform with weapons and some gangsters of Rokkhi Bahini charged into the guest house to kidnap me. I was taken to Mujibbat Torture Camp in front of Dhaka College; I was brutally tortured and later Sheikh Kamal gave the orders to one of his gangsters to kill me but by the grace of Almighty God that person realized my religious and spiritual status and decided not to continue with killing me instead dropped me off to Lalbagh Police Station at Dhanmondi Road with Officer in charge Mr. Helal Uddin. Although the OC of Lalbagh was afraid but worried about my safety and security from Sheikh Kamal's brutal aggression. He forwarded me to magistrate court of Dhaka and granted my safe custody without forming any charges and sent me to Dhaka Central Jail; accordingly I admitted at the medical center inside the jail. The deputy inspector general of Prison Mr. Kazi Abdul Awal and officer in charge of Dhaka Central Jail Mr. Sahamsur Rahman, Jailer and other senior staff members all knew me personally; they all were surprised and discussed how the new born country's innocent peoples were victimized and there were no rule of law, "how can the innocent people survive?".

On June 20th of 1972 I managed to officially visit Sheikh Mujibur Rahman self-proclaimed father of the nation with Hafez Monir Hossain at his 32 Dhanmondi Residence; I reported all the immoral activities of Sheikh Kamal and his so-called political gangsters and we also explained our humanitarian work and other philanthropic works. Unfortunately, Sheikh Mujib did not take any heed to take any action against his immoral son Sheikh Kamal or his immoral cousin brother Shiekh Faziul Hoque Mani and their gangsters. Accordingly we proposed Sheikh Mujib to be the Chief Patron along with President Justice Abu Syed Chowhdury for the Bangladesh United Nations Associations Organizations (BUNA); Sheikh Mujib was certainly happy to be Chief Patron and called for Works Minister Mr. Motiur rahman (MP) around 12:30 am during our meeting at his Dhanmondi residence. He directed the Works Minister to urgently order the allotment of Building from any abandoned Pakistani property for smooth functioning of new Bangladesh UN Association organization.

Accordingly on July 1" of 1972, the honorable Works Minister Mr. Motiur Rahman Ministry of Works and Secretary Kazi Jahedul Islam of Ministry of Works had been pleased to allot 72, Midford road. Imam Gonj, Dhaka - 1205, near Lalbagh Police station under the abandoned property regulation control act of 1972; After I received the legal documents of ownership of the Property from the government's respective department; I established and maintained the office of Bangladesh United Nations Association from October 1972 till 1977. Unfortunately one of the gangster of Awami League Officer in Charge Akram Hossain of Lalbagh Police Station with his police staffs broke the 72 Midford road building's lock and illegally occupied the building; he also destroyed my official documents, stored relief goods such food, medicine and cash money for the relief rehabilitation about 5 million Bangladesh Taka. On 3'*^ January of 1977 I called Akram Hossain Officer in Charge of Lalbagh PS, after the telephonic conversation; he illegally arrived at my premises at the spiritual headquarter of 42/2 Holy Dayera Sharif Azimpur, Dhaka, on 4^*^

of January 1977, and he threatened me, if further I continue to file any case against him regarding my property at 72 Midford Road than "his gangsters or him will kill me". On 5*^ January at Midnight 12:15 AM OC of Lalbagh Akram Hossain along with his gangsters by force took my authorized licensed revolver and shotgun, which I had purchased from United States and kept for my personal security; I had all the necessary government licenses for both the guns. Unfortunately, If anybody were to complain about the gangsters of Police of the ruling Awami League party, they can be killed at any moment. This has been my life and death situation in Bangladesh. Since 1972 I had many undesirable experiences against the Sheikh Mujib and his Awami League Gangsters; they had tried to kill me several times and still continue to threaten my life today. It is very normal for them; they have killed thousands of people to rob their properties.

I have seen Sheikh Mujibur Rahman not to be helpful for the people of Bangladesh; he was under pressure through his political party's gangsters and his family members particularly his son Sheikh Kamal and his cousin brother Sheikh Faziul Hoque Moni. However, the regime of Sheikh Mujib and his immoral son Sheikh Kama! was not successful to kill me, and could not stop my social and humanitarian services for the people of Bangladesh. This information elaborately discussed inside the World Human Rights Service Council Chairperson Legal Affairs Dr. Richard T. Jordan's transparent Country report of Bangladesh and India also published in Book titled "My life and My Prophecy" ISBN# 978-0-578-80663-1.

I pursued the work for Bangladesh's recognition to attain the attention of United States and United Nations; I managed to get the attention of Secretary General Kurt Waldheim and other international community. At that time US State Senators and Secretary of State Henry Kissinger directly opposed and given the veto to not recognize Bangladesh because of their friendship with West Pakistan's President Mr. late Zulfiaqr AN Bhutto. However, Honorable Senator Ted Kennedy along with you honorable President as you were the youngest Senator of Delaware, whom strongly supported to recognize new born Bangladesh after many debates and cross debates at the United States House of Senate. Unfortunately Sheikh Mujib's fascist government and her daughter's current fascist government forget your and Ted Kennedy's remarkable contributions and active support for the recognition of Bangladesh. This is the situation of Bangladesh since 1972; I had been the victim by the ruling authority of Awami League party and their gangster governments till now.

There had been many false fabricated civil and criminal cases that had been started against me from magistrate court, district court, high court, martial law court to Supreme Court and appellate division court but I had won all of my cases in all the courts by properly attending and fighting against all false and fabricated cases; finally the judgment orders were passed by the respective courts in favor of me. The Awami League's political hypocrite gangsters of Indian RAW targeted to kill me many times; but I am a spiritual person working 18 hours a day to provide

help and support for the innocent peoples of Bangladesh; please find more details on book titled "Dayemi Complex Bangladesh, 700 Years Old Sufi Dynasty of Holy Azimpur Dayera Sharif' ISBN: 97805-786-3824-9.

But the immoral Sheikh families continue to wage fight against me, even to this day; Sheikh Hasina's nephew and Awami League's greatest gangster Sheikh Mani's son Barrister Fazle Noor Taposh and other terrorists directly tried to kill me at my Spiritual Kingdom Holy Azimpur dayera Sharif located in Dhaka, Bangladesh. Also on 2nd November, 2009, Sheikh Hasina's family gangsters along with dangerous Awami league's born brought up criminals whom also killed 57 army officials on February of 2009 by the active cooperation of Indian RAW inside the BDR headquarter Pilkhana Dorbar Hall, under the direct supervision of so-called barrister Fazle Noor Taposh at the time candidate of undivided mega city Dhaka's Mayor in 2009, who intentionally attacked my United Nations affairs office located at 80/1 VIP Road, Kaikral, Romna, Dhaka headed by Romna PS OC Noman and SI Jafor All. There were about 40 armed gangsters with machine guns, grenades stormed into my Kaikral Office at Dhaka, Bangladesh.

The current illegal fascist Prime Minister Sheikh Hasina have destroyed the back-bone of Bangladesh and holding 160 million Citizens of Bangladesh in complete hostage. I had been working for the humanitarian cause and established over 100s of Educational and religious institutes and Orphanages in Bangladesh through Religious and humanitarian organization "Dayemi Complex Bangladesh" with the help of UN aids and governmental subsidiary fund; the Dayemi Complex Bangladesh's humanitarian institutions and projects can be valued over billion dollars. It may be mentioned here that. The Dayemi Complex Bangladesh was designated as the Peace Messenger Organization by UN Secretary General in 1985 also earned a special consultative status with United Nations Economic and Social Council (ECOSOC).

I had been fighting to safeguard the humanitarian organizations and institutions of Dayemi Complex Bangladesh against a hypocrite Faizi Mohammadi Ahmedullah and his gangsters also against illegal Prime Minister Sheikh Hasina's nephew Sheikh Fazle Noor Taposh current Mayor of Dhaka City South, his gangsters as well as many corrupted police officials. I had filed several Civil and Criminal cases and logged FIRs against them; Writ petition of Bangladesh Supreme Court 1875 of 2003, Bangladesh Supreme Court Civil Revision Case Number 3334 of 2004 and many other criminal cases; currently most of the cases are pending

at the Bangladesh Supreme Court's Appellate division. Chief Metropolitan Magistrate Court (CMM) Dhaka also 5[^] district judge court Dhaka. Finally, after 12 years of fighting the Bangladesh Supreme Court had passed a Judgment order in favor of me to take appropriate action and punishment against all the accused whom had illegally occupied my land, properties, offices, institutes and orphanages since 1996; the Supreme court of Bangladesh Appellate Division (Criminal Appellate Jurisdiction) Criminal Appeal No. 8 of 2012 (arising out of criminal petition for leave to appeal no. 382 of 2010) bearing Bangladesh Police station Lalbagh Police Case# 48(9) of 1999 Dhaka, which had received a judgment order by Bangladesh Supreme court to curb down Faizi Mohammadi Ahmed Ullah and his gangsters to recover my projects and properties along with the 100s of institutions; although the case is currently pending at Chief Metropolitan Magistrate court (CMM) of Dhaka along with a Money Suit Charge of 100 million BD Taka for plenty of false cases against me; accused Faizi Mohammad Ahmedullah (former) and IGP Nobo Bikromtripura Deputy Inspector of Police Mr. Mokbul Hossain Bhuiyan, Assistant Police Commissioner F R Chowdhury of Nobinagar Circle B-Baria and Officer In Charge Golam Rahman of Lalbagh Police Station Dhaka, Sub-Inspector Sajjad Hossain of Lalbagh Police Station Dhaka along with Judicial Magistrate Sheikh Tofael Hassan of CMM court Dhaka for their misconduct and gross violation of Human Rights and violation of Bangladeshi Citizen's fundamental rights of the Bangladesh constitution Article 103. All Supreme Court judgment orders and complains are pending with the respective courts, unfortunately at this time in Bangladesh, there are no rule of law especially under fascist Prime Minister Sheikh Hasina and her gangsters. However, because of the illegal influence of Sheikh Hasina's fascist government influenced by Indian RAW and her nephew Fazle Noor Taposh, his gangsters and corrupted law enforcement agencies and its officials; the judgment of Bangladesh Supreme court was not implemented and I have not been able to recover the humanitarian organizations and institutions.







Left Behind, 240,000Pakistanis Languish in Bangladesh

ANGPUR, Bangladesh — The world ceaselessly chums out human tr/edy. The newly conquered. Newly dispossessed. Newly hungry. Newly diseased. Newly destitute. One calamity overtakes another, and the 240,000 "stranded Pakistanis of Bangladesh' know they are the leftover unfortunates of distant yesterdays.

For 29 years, they fux, been spread across this nation in 66 squalid camps, each a tightly packed thatch Fitetrap. They live as refugees, though theirs is a more peculiar predicament They did not lefve their country: their country left them.

In 1947, the newly created Islamic Republic of Pakistan had an East and a West, two large chunks of territory with the behemoth India in between. In 1971, the Ea.st won a war of independence and became Bandladesh. Left behind were those who had been loval to Pakistan, some of them active collaborators. In victory, they would have been patriots. In defeat they were traitors.

They sold their property or had it confiscated. They were herded into camps, often for their own protection. Their decided preference waste leave the new nation and go to the part of Pakistan that still existed. They expected to be welcomed. Their waiting began. Three decades later, they wait still.

But for what? Once, they thought of Pakistan as the promised land. Now, many are unsure they would go even if they had the chance. Steeped in inertia, enmeshed in poverty, they are waiting because wailing is what they do. Even the most stalwart now wonder whether they have sac- riFiced their lives to a sad folly.

"Look at me: I am going to die here." said Mohammed Jainul Abedin, a fiail 70-vear-old. He lives in a camp in Rangpur, a small city in the nmthwest. A stroke has disabled his arm. His spirit suffers a paralysis as well. His face crumpled with tean. "Who thought we would spend 30 years living in a filthy

waiting futilely as Bangladesh and Pakistan figure out which is to keep them.

Commissioner for Refugees in Dhaka, the capital of Bandladesh, "It's quite pitiful, f'ally And no one seems to be doing anything about it." A

NDEED, his own agency offers no help. The stranded Pakistanis do not qualify under the United Nations definition of refugees. They are waiting to flee, but have not yet fled. Here in Bangladesh, as well as in Pakistan, people in the camps are known as Bilhru. In 1949, when India and Pakistan were loosed nom the British empire, millions of Muslims left largely Hindu India, some going east, some west. Until a military coup in Pakistan last October, Mohammed Arshad Chadri held the feckless position of counselor general for the return of stranded Pakistanis. He is a disappointed man.
